# **Steps to Complete the Housing Agreement Process:**

## Prior to completing your housing agreement, you will need:

- A credit card or banking information for an electronic check for the \$175 advance housing fee. This is non-refundable after May 1 (regardless if you have cancelled your admission to the University after this date). It is only refundable on or before May 1 if you officially cancel your admission.
- 2. Date of meningitis vaccination. This information is required. Your vaccination date can be obtained from your physician or your high school records. A waiver can be electronically requested when vaccination is medically contraindicated.
- 3. Slippery Rock University's primary form of communication will be via your SRU email account. Please log in frequently, or forward your University email to another personal account, to be sure you receive correspondence. All first-year students are required to live on campus at Slippery Rock University. If you are a first-year student, you may request an exemption from this residency requirement policy if you meet any of the following conditions:
- Commuting from permanent home address (within 60 miles of campus) Upload a notarized letter confirming this.
- Fully online course schedule (copy of class schedule).
- Over the age of 21 on or before December 31 of current year (student record will verify)
- Married (upload marriage certificate)
- Dependent child/children in student's custody (upload birth certificate, custody order, or copy of most recent student tax return)
- Active military service or honorably discharged (upload DD220, copy of orders, or DD214)
- Will have over 48 credits by August 15 or have already completed 4 regular full-time semesters (class schedule will verify)
- Student serves on the Slippery Rock Volunteer Fire Company & Rescue Team as a live-in firefighter or EMT (a signed volunteer agreement will verify)
- Student is part-time (upload statement, class schedule will verify)
- \*Other (upload detailed statement with any supporting documents)

\*This request will be reviewed by a campus committee every 2 weeks. Exemption from this requirement of living on campus is NOT guaranteed. Do not sign an off-campus lease until you receive an approved exemption statement via SRU email.

### **STEP 1: Sign the Housing Agreement**

- Log into MyHousing Portal: <a href="https://reslife.sru.edu">https://reslife.sru.edu</a>
- Username: Your SRU ID (email account)
- Password: Your password is the same one you use to check your SRU email, or if you have never logged in before, it is your six-digit birth date (mmddyySru).
- Select "Application/Agreement" on the menu.

- Select the Fall agreement.
- Read the agreement carefully; This is a legally binding contract for the entire academic year (two semesters).
- Sign the agreement electronically. This will serve as your signature for the entire academic year. Click "continue."

NOTE: Students residing on-campus are required to have a meal plan. The University will automatically invoice you for weekly 14 meal plan as outlined in your housing agreement. You may log back in to your MyHousing portal to change your meal plan after July 1st. The meal plan may be adjusted one time until a designated date in September.

#### STEP 2: Complete the "My Information" Section

- Students requesting specific housing due to medical issues must be registered with the
  Office of Disability Services. The Office of Housing and Residence Life cannot
  accommodate requests to medical concerns unless you are registered with the Office of
  Disability Services.
- Students residing in residence halls are required to have received the meningococcal vaccination. Please provide the date you received the vaccination or waive the vaccination.
- Students have the option to list an identified gender if different from the gender assigned at birth. If students wish to explore options to live with a friend of another gender, or wish to be contacted to discuss gender inclusive options, you can indicate that and a staff member will reach out to further discuss options and preferences.
- You will have the option to give a preference on campus area (Residential Suites, Buildings A-F or Traditional Halls, North and Rhoads). This is only a request and cannot be guaranteed.
- You will have the option to give a Living Learning Community (LLC) preference. After
  reviewing the Living-Learning Community spreadsheet in this booklet, or online, if you
  believe one of those communities would be a good fit for you personally or
  academically, make it a preference.
- Please note: If you select to live in an LLC and your major matches the LLC requirement, you will be automatically approved. If not, your application will be reviewed.
- If you or your roommate are applying for an LLC, you must be aware that both roommates must apply to the LLC and approved or the request cannot be honored.
- After you had selected your preferences, click "Continue."

#### STEP 3: Complete your Addresses/Contacts.

 Please complete Parental Verification contact. This is required. Your parents will receive a verification code sent to their email address. They will then need to log into the housing portal (as you) and enter the code. If they do not receive an email with the verification code, make sure to check in the spam or junk folder. If it does not arrive, please call our office for assistance. 724.738.2082.

## STEP 4: Complete your Living Requests (Optional).

- We encourage students to be realistic about what to expect during the housing selection process and plan for multiple options. You will have the option of listing your top 3 room style choices, in order of preference, considering your priorities. These are only preferences and cannot be guaranteed. It is helpful if your matched roommates select the same room styles.
- After you had selected your preferences, click "Continue".

## **STEP 5: Pay Housing Fee**

- Next, you will pay the housing fee. This step is not optional and without the fee, your
  application will not be processed. After you have completed both the agreement and
  submitted payment, you will be directed to sign your meal contract. Changes to your
  dining plan may be made at the beginning of July via the MyHousing Portal. If you are
  unable to pay the \$175, please contact the Office of Housing and Residence Life for
  assistance.
- You will receive an email via your SRU email account confirming that you have completed Step 1.
- If the student is under 18 years of age, a verification will be sent to the parent email entered in the "Addresses/Contacts" section.
- Click Home.

You may search for the name of your intended roommate or roommates at this time. If you can't find in the system, please review the \*reasons why below.

GROUP 1: New freshmen who have completed housing application before February 28, 2025 will be assigned in March.

GROUP 2: New Freshmen who have completed housing application between Feb. 28 – March 31 will be assigned in April.

Students in these groups will be assigned on a rolling basis in March (group 1) and April (group 2). Once assigned, that assignment will show in your MyHousing portal. Any fully matched roommates or preferences marked on your application will be considered when assigning. After you have an assignment, if you would like to request a different building or room style, you can fill out an "Alternate Room Request" (form opens March 3) on the MyHousing portal; any/all roommates should fill this out to have a matched

request. These room change requests will be monitored and adjusted up through August 1.

GROUP 3: For any student who has completed their housing application after March 31: Students in this group will be assigned on a rolling basis, and be assigned prior to your chosen on-campus orientation date.

\*Reasons why you can't find your intended roommate(s) to send them a roommate request:

- 1. Did they submit their \$90 enrollment fee and complete their housing application?
- 2. Do they already have a housing placement?
- 3. Did they select an LLC which is different than yours?
- 4. Is their application incomplete (parental verification for those under 18)?
- 5. Did either of you apply to the Honors LLC or ROCK Athletics LLC and was your request approved?
- 6. Do they already have a housing assignment?
- 7. Is your roommate an upper-class student? (you can only see other new freshmen in the que) If this is the case, contact Office of Housing and Residence Life for assistance.

#### Helpful hints:

If you mark that you would like to live in a Living and Learning Community, you will only see rooms open in that particular building which are available for you to select.

Building A: College of Health, Environment and Engineering and College of Health Professions

Building B: Select floors ROCK Athletics LLC and College of Business

Watson Hall: College of Education and Honors Only

Building D: College of Liberal Arts

There are no LLC's offered in traditional housing (North and Rhoads Halls)
